I. Statement of Work

Project Synopsis:

The project is described as “Supply and delivery of diesel fuel for the generators at the U.S. Consulate General Erbil/IKR.

Contractor’s Requirements:

- 1- Supply and deliver diesel fuel to the U.S. Consulate General (CG) Erbil, Ankawa compound.
- 2- The Contractor is responsible for providing all necessary materials and labors to complete the delivery to CG Erbil.
- 3- The Contractor is responsible for taking a sample of the diesel fuel to the KRG laboratory for analysis on each delivery.
- 4- The fuel quality shall meet the following parameters:
 - Appearance (ASTM D4176) – clear and bright
 - Color (ASTM D6045) – 2.0 maximum
 - Specific Gravity @ 15.5 C (ASTM D4052) – 0.850
 - API at 60 F
 - Total sulfur content (ASTM D4294) – 8000 PPM maximum
 - Flash point, CCC (ASTM D6450) – 60 Celsius minimum
 - Pour point (ASTM D97) – minus 9 Celsius maximum
 - Cetane index (ASTM D976) – 50 minimum
 - Kinematic Viscosity @ 40 C (ASTM D7042) – 5.6 maximum
 - Calorific value (gross) EST – 10800
 - Water content, Free (ASTM D2709) – none
- 5- The hose shall be connected to the pipe fittings installed on the diesel fuel tank. Hose can be dropped through the diesel tank cover.
- 6- The Contractor is responsible for repairing/replacing any damages caused during the delivery. The Contractor shall fix all damages per the DoS standards and codes. The Contracting Officer’s Representative (COR) must approve the correction that is made by the Contractor.
- 7- The Contractor shall deliver the fuel within 24 hours from a call from the COR. The delivery shall be executed during normal (CG) Erbil work hours (0800 – 1700) Sunday through Thursday - in other words, the work shall be completed during the days and hours mentioned above.

- 8- Diesel fuel shall be partially delivered as per the COR's request. Total delivery calls shall not exceed 15 times.
- 9- The truck should be clean and washed from outside before entering the compound. Fuel delivery will not take place if the truck is dirty (diesel residuals, oil, soil, etc.).
- 10- The truck shall be inspected by the Contractor before delivery. No leaks are permitted. The filter of the pump shall be replaced/cleaned as needed. The filter shall be inspected by the Contractor and the COR before diesel is pumped out to the generators' tanks.
- 11- The Contractor is responsible for cleaning up the area after each delivery using correct and approved cleaning materials. The COR and the CG Erbil Safety Coordinator must approve the materials.
- 12- The Contractor must provide a list of names/information for the worker/truck to the COR 24 hours in advance to get compound access approval.
- 13- The Contractor is responsible for following all safety and healthy requirements. The Safety Coordinator shall provide a safety briefing to the Contractor.
- 14- The Contractor is responsible for providing proof of Defense Base Act (DBA) Insurance within 10 business days from the award date.

II. Delivery Location and Time

A. The Contractor shall deliver all ordered diesel fuel to the U.S. Consulate General in Erbil. The address is:

B. Any Contractor personnel involved with the delivery of the diesel fuel shall comply with standard U.S. Consulate General Erbil regulations for receiving supplies. The Contracting Officer's Representative (COR) will be responsible for instructing Contractor personnel at the time deliveries are made.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the purchase order. The role of the Government is to monitor quality to ensure that purchase order standards are achieved.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Reasonable inquiry has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(2) The Offeror shall submit with its offer the IRS Form W-14. If the IRS Form W-14 is not submitted with the offer, exemptions will not be applied to any resulting contract and the Government will withhold a full 2 percent of each payment.

(f) If the Offeror selects “is” in paragraph (d)(1) and “partial or no exemption” in paragraph (d)(2) of this provision, the Offeror will be subject to withholding in accordance with the clause at FAR 52.229-12, Tax on Certain Foreign Procurements, in any resulting contract.

(g) A taxpayer may, for a fee, seek advice from the Internal Revenue Service (IRS) as to the proper tax treatment of a transaction. This is called a private letter ruling. Also, the IRS may publish a revenue ruling, which is an official interpretation by the IRS of the Internal Revenue Code, related statutes, tax treaties, and regulations. A revenue ruling is the conclusion of the IRS on how the law is applied to a specific set of facts. **For questions relating to the interpretation of the IRS regulations go to <https://www.irs.gov/help/tax-law-questions>.**
